c) In addition customers are responsible for ALL additional veterinary fees related and unrelated to breeding, farm call splits, Airport Courier fees, container returns, farrier fees, etc.

b) Mare Owner Contact Information Page

c) Copy of Negative Coggins & Health Certificate

d) Negative EVA (Equine Viral Arteritis) Test within 30 days of Arrival or documentation of an EVA vaccination from your vet 30 days prior to arrival

e) Completed Copy of Breeding Contract to Chosen Stallion

f) Copy of Registration Papers front and back

g) Completed Copy of Transported Semen Receiving Center Contract

2) General Terms and Conditions:

a) Breeding season will begin on February 1st and close July 15th

b) Mare owner agrees to leave the mare at ALL SEASONS FARMS, LLC in order to confirm a thirty-five day positive pregnancy exam; unless previous arranged by both mare owner and ALL SEASONS FARMS, LLC. In the event Mare Owner does not leave the mare at the breeding facility for thirty-five days following last breeding for purposes of a pregnancy test, mare owner assumes all responsibility for pregnancy testing. For no reason if the mare does not become pregnant shall the mare owner hold ALL SEASONS FARMS, LLC and their representatives liable.

c) It is the mare owners responsibility to obtain the Breeder's Certificate from the participating/contracted stallion owner.

d)Prompt Payment: Mare Owner will be invoiced at the first of each month for all mare care charges including board veterinary expenses, farrier fees, specialized dietary feeds, etc. Invoices are to be paid in full and received by ALL SEASONS FARMS, LLC by the 20th of the month. If said invoices are paid by credit card, ALL SEASONS FARMS, LLC will add a 3% surcharge to invoiced amounts to cover credit card fees. ALL fees shall be paid in full prior to the mare's departure from ALL SEASONS FARMS, LLC.

e)Release/Hold Harmless: Mare owner understands and agrees that ALL SEASONS FARMS, LLC and/or their representatives shall be held liable for any accident or sickness, disease, death of the mare and/or foal. ALL SEASONS FARMS, LLC., strongly recommends that mare owner carry theft and/or major medical and mortality insurance on all animals boarded and in the care of ALL SEASONS FARMS, LLC.

f) All action with respect to this contract, will be governed by the laws of the State of Kentucky and venue of any disputes arising from this contract shall be in Anderson County, Kentucky.

g)WARNING-UNDER KENTUCKY LAW, AN EQUINE PROFESSIONAL IS NOT LIABLE FOR AN INJURY TO OR THE DEATH OF A PARTICIPANT IN EQUINE ACTIVITIES RESULTING FROM THE INHERENT RISKS OF EQUINE ACTIVITIES.

h) PLEASE NOTE: It is the mare owners responsibility to be aware of all issues relating to the Kentucky Breeders Incentive Fund. All breeds rules and regulations may vary. ALL SEASONS FARMS, LLC. Is not responsible for monitoring eligibility on stallions.

i) Mare owner's signature on this contract states that he/she has read and fully understands all of the terms and conditions outlined. No other agreements, promises, or representations, verbal or implied, are included herein unless specifically stated in this written agreement. This contract is made and entered into in the State of Kentucky, and shall be enforced and interpreted in accordance with the laws of said State. In the event one or more parts of this contract are found to be unenforceable or illegal, the other portions hereof shall be deemed in full force and effect.
